b. Tax Levy

WHEREAS, the voters of the Quogue UFSD approved the proposed General Fund budget of \$10,475,781 for the fiscal year 2024/2025 at the Annual District meeting held on May 21, 2024; and

WHEREAS, revenues in the total amount of \$1,612,648 are projected from other sources.

NOW, THEREFORE, BE IT RESOLVED that the Board of Education authorizes a tax levy on the total taxable assessment value of \$4,454,929,072 in the amount of \$8,863,133 for school purposes;

AND, BE IT FURTHER RESOLVED that the Board of Education authorizes a tax levy in the amount of \$1,217,263 to be raised for the Quogue Library for the Quogue Library Operating Fund;

AND, BE IT FURTHER RESOLVED that the total amount of taxes for these purposes is \$10,080,396.
