WHEREAS the bids were opened and read aloud on November 2, 2023; and

WHEREAS, the Quogue UFSD has determined that the bid submitted by Turf Tek USA in the amount of \$476,000 constitutes the lowest responsible bidder and, therefore, has determined to award such bid to Turf Tek.

NOW, THEREFORE, BE IT RESOLVED that the Board of Education of the Quogue UFSD hereby awards the contract for the Playground Renovation Project at the Quogue School, 10 Edgewood Road, Quogue, NY 11959, to Turf Tek USA as the lowest responsible bidder at an amount of \$476,000, in accordance with Base Bid No. GC-1: General Construction.
